Recommendation: Minor Revision

Comments:

- 1. It is suggested that this paper be proofread to avoid grammatical errors.
- 2. It is suggested to provide some description about the woven craft industry in Indonesia.
- 3. There are several sentences that can be regarded as "unfinished" and therefore potentially create confusion (examples: page 3 line 52; page 3 line 53,54, and 55; page 5 line 31 and 32; page 7 line 35)
- 4. It is suggested to explain the rationale of each hypothesis so it can be easily scrutinized (see page 4).
- 5. The fifth hypothesis does not firmly correlate with its argument (maybe due to lack of scientific evidence). It is suggested for the author to improve the argument of the fifth hypothesis.
- 6. Based on the reviewer's opinion, there are some paragraphs in which a logical or theoretical connection between one argument with another argument is weak. Page 9 is one of the examples. Referring to Michael Porter, differentiation and low cost are strategies that cannot mutually exist in the same point in time. The similar argument was also stated by Treacy and Wiersema (1997).
- 7. The author interchangeably uses "woven SMEs", "craft SMEs", and "woven craft SMEs." It is suggested to consistently use the same terminology.

#### Additional Questions:

- 1. Originality: Does the paper contain new and significant information adequate to justify publication?: Yes, a group of studies about the dynamic capability that is based on traditional knowledge is still difficult to be found. Moreover, the paper similarity index is only 14 percent (References are included).
- 2. Relationship to Literature: Does the paper demonstrate an adequate understanding of the relevant literature in the field and cite an appropriate range of literature sources? Is any significant work ignored?: Yes, this paper tries to cover every variable involved in the study. However, the purpose of the elaboration of this seems to be unclear
- 3. Methodology: Is the paper's argument built on an appropriate base of theory, concepts, or other ideas? Has the research or equivalent intellectual work on which the paper is based been well designed? Are the methods employed appropriate?: Yes, in general, this paper cites a lot of research papers that belong to a similar body of knowledge although several "cognitive leaps" can be found in the paper. The selection of Covariance Based SEM as the tool of data analysis can be regarded as appropriate
- 4. Results: Are results presented clearly and analysed appropriately? Do the conclusions adequately tie together the other elements of the paper?: Yes, the results are adequately explained. The conclusion is also properly laid out as it integrates the elements succinctly and also provides a sense of closure
- 5. Implications for research, practice and/or society: Does the paper identify clearly any implications for research, practice and/or society? Does the paper bridge the gap between theory and practice? How can the research be used in practice (economic and commercial impact), in teaching, to influence public policy, in research (contributing to the body of knowledge)? What is the impact upon society (influencing public attitudes, affecting quality of life)? Are these implications consistent with the findings and conclusions of the paper?: The theoretical contribution of this research is adequate. However, the paper does not clearly reveal the implication of this research from various stakeholders' points of view. Hence, the benefits offered by this research is somewhat limited
- 6. Quality of Communication: Does the paper clearly express its case, measured against the technical language of the field and the expected knowledge of the journal's readership? Has attention been paid to the clarity of expression and readability, such as sentence structure, jargon use, acronyms, etc.: The quality of communication must be further improved especially the writing structure. Moreover, the flow of the arguments is not "smooth" and systematic and therefore should be improved
